

# ESSER III: American Rescue Plan (ARP) Spending Plan



## Introduction

The CARES, CRRSA, and ARP Acts provide vital support to schools as they work to safely reopen, maximize in-person instructional time, and address the impact of the COVID-19 pandemic on students, educators, and families. We are currently working to gather and analyze vital information from school and community stakeholders to inform our planning. We will implement actionable strategies to meet the urgent needs of students, educators, and families as we return to and safely sustain in-person instruction, address the educational inequities that have been exacerbated by the COVID-19 pandemic, as well as students' social, emotional, mental health, and academic needs.

## Overview: ESSER III ARP Funding

The following questions are meant to guide schools in determining if an activity is an allowable use of funds:

- Is the use of funds intended to prevent, prepare for, or respond to the COVID-19 pandemic, including its impact on the social, emotional, mental health, and academic needs of students?
- Does the use of funds fall under one of the authorized criteria of ESSER funds?
- Is the use of funds permissible under the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards?

## A Collaborative Approach

A critical component of our planning involves inviting input from our internal and external stakeholders to inform the plan for the expenditure of these **non-recurring funds**. Stakeholders were encouraged to provide both short- and long-term approaches. As we continue to develop the plan we will :

- survey school and community stakeholders as necessary;
- prioritize spending on one-time, non-recurring expenses over 3-years; and
- create evidence-based initiatives to invoke academic and social-emotional recovery from the COVID-19 pandemic for students, educators, and families.

## Preserving the Operating Budget

ESSER III ARP funding is temporary and must be encumbered for use by June 30, 2024. Initiatives created and/or enhanced for the purpose of COVID-19 pandemic recovery will need to be thoughtfully phased-out by June 30, 2024. In order to minimize disruption of core academic school programming, we will take the following approach:

- *Program initiatives requiring additional staffing:* Generally, hiring will be advertised as **temporary** based on the unsustainable nature of the ESSER funding and will not be added to the annual operating budget.
- *Program initiatives (non-staffing related):* Purchased services and supplies and materials will be viewed as one-time expenses over the course of the funding time period and not added to the annual operating budget.
