SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. - 1. In the space provided below, please describe how the LEA meaningfully engaged a diverse and representative set of the applicable stakeholders in developing a plan to use these funds and implementing that plan.**

In order to meaningfully engage a diverse and representative set of stakeholders in developing a plan for the expenditure of these funds, the LEA created two surveys. The first survey was disseminated to internal faculty/staff and the second survey was disseminated to the external school community, including families. The surveys asked stakeholders a series of questions meant to solicit feedback and input to help inform decision making and final proposals for the expenditure of the funds. Input included ideas for accelerating student learning and growth and incorporated ideas for the development of the whole child including academics and social emotional/mental health support. Both surveys asked how we could not only support students, but faculty/staff and families through the development of this plan. The data and information from these surveys were collected, analyzed, and sorted into larger subcategories to assist the LEA in meaningfully allocating the funds to support all areas. In addition, the LEA worked directly with teacher leaders throughout the district to solicit further input from Professional Learning Communities. Finally, district and building administrators engaged in research of best practice options for accelerating student learning and provided input and ideas regarding how we could best support this in our schools and district. The collection of this input from teacher leaders and administration, along with the development of the plan, were facilitated through regular meetings rhythms and routines.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

A part of our plan includes setting funds aside for the next two years (2022-23 and 2023-24) to allow for the purchase of: additional personal protective equipment (PPE) for students and staff; cleaning supplies and cleaning instruction; and any classroom materials necessary for compliance with the most recent CDC guidance on reopening schools in order to continuously and safely open and operate schools for in-person learning. In addition, we also plan to use the funds to update the air quality in our high school gymnasium as it is well beyond useful life and is at a central location for our high school. We are planning to use a portion of the funds to contract for additional nursing services in order to follow any mandated testing protocols. Finally, our nursing staff will be attending any COVID taskforce meetings that take place throughout the school year to ensure we have, and are in compliance, with the most up-to-date CDC guidance on reopening schools.

4. **In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

We plan to use a number of data points to identify student needs and monitor student progress. These data points will be derived from our yearly benchmark assessment schedule and include but are not limited to: i-Ready Reading and Math, the Early Literacy Profile, High Frequency Words, Foundations, and Fountas and Pinnell benchmark assessments. In addition, we will implement math fluency probes through the year to monitor student progress. We will also use data from pre- and post-unit assessments and classroom formative assessments to adjust for student progress and promote accelerated growth. Benchmark assessments are given three times/year and data is analyzed to determine the supports students need through tiered intervention services. Further, with the use of these funds, we intend to purchase an all-in-one data insight and tracking platform to assist us in the analysis and tiered support for students. We also intend to purchase a universal screening tool to assist us with the identification of social emotional support for our students. The additional Academic Intervention Services specialists and Rtl Coordinators put in place using these funds will hold responsibility and ownership over this data to appropriately group students for interventions and assist with progress monitoring throughout the year.

5. **In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.**

Approximately 65% of our funds will be dedicated to combat the academic impact due to the loss of instructional time. First and foremost, we will target staffing to support learning loss initiatives. We will use these funds to hire seven (7) support positions including: Academic Intervention Services specialists and multiple Rtl Coordinators to assist with analysis of data and provision of tiered intervention services to students. These seven (7) temporary positions are to be evaluated on an annual basis to determine the necessity of continuity. We will also use these funds to hire an additional special education teacher, for one year, to provide targeted support at multiple grade levels for students experiencing universal skills deficits due to learning loss. With these approved funds, we will establish two temporary, full-time building substitute positions to support consistency in learning on a daily basis.

We will use these funds to enhance and establish additional summer programming for students. Summer programming will include: hosting a summer learning program targeted to support our English Language Learners in grades 7-12; providing additional high intensity tutoring for students in targeted grade levels needing additional support; providing targeted literacy support for our students in grades 7-12; and enhancing the amount of staffing to support our summer learning academy. We will also establish summer student workshops aimed at supporting all students with skill development, social emotional support, and enrichment.

A portion of our funds will also be used to support teacher acquisition of knowledge and skills to support all students at Tier 1. The LETRS professional development course will support all teachers in understanding the science of reading and foundational literacy skills for continued student growth. To supplement this program we will also set aside a portion of these funds to purchase additional materials and supplies aimed at supporting our most at-risk readers in the classroom. We have also set aside funds to provide teachers with blended learning professional development specific to Math Expressions to assist them in improving pedagogical practice for implementation of math routines at Tier 1.

Finally, we intend to set aside funds to provide additional opportunities to support students with academic and social emotional needs.

We will institute a homework help program, staffed by classroom teachers, to support students with academic and social emotional skill building. These funds will also provide identified students with access to a 24/7 tutoring and homework assistance platform to continuously promote their growth and success.

The remaining funds will be allocated to support the ongoing operation of the LEA. We have allocated funds for staffing. The funds will support a stipend for the development of a school to career program. We have also allocated a portion of these funds for clerical salaries planned to be attributed to specific record-keeping, audit requirements, and tracking of the ARP funding related to accompanying school initiatives. A portion of these funds will also be allocated for substitute nursing services to support COVID testing and protocols as well as support for our nursing staff that will attend COVID task force meetings throughout the year. We have set aside funds to ensure availability of additional personal protective equipment (PPE) for students and staff. In addition, these funds will be used to add two additional days of mental health support for students throughout the district.

In order to meet the needs of all learners, and promote an inclusive environment for learning, we have set funds aside for multiple stakeholders to take part in diversity, equity and inclusion training and deeper systems work with the NY Metro Center to ensure sustained, systemic change of critical systems that support students. A portion of the funds are also allocated to provide school personnel with additional professional development with regard to Professional Learning Communities and Response to Intervention work to promote and support the success of our students. To supplement this work, we are also planning to acquire an all-in-one data tracking and insight platform aimed to assist faculty and staff in identification of at-risk students and provision of tiered services to support their continued learning. Using these funds will also allow us to engage in Phases 3-4 of our work with the Children's Institute aimed at whole child development including social emotional support and skill acquisition.

The funds will allow us to purchase a platform to collect information related to the digital equity survey collection SIRS information required for reporting purposes for the next two years until we are able to develop an internal system to support the work. We will also use the funds to integrate the use of interactive flat panel displays for classrooms in an effort to continue integrating technology and blended learning opportunities into instruction. Finally we will allocate some of the funds to make updates to our air quality HVAC system.

In planning for the allocation and expenditure of these funds, we kept the needs of students and the academic impact of lost instructional time at the forefront of our planning. Specifically, we have allocated funds to hire an additional 1.0 FTE ESOL teachers to specifically support our growing population of ELL students within our district. We have also allocated funds to hire a 1.0 FTE school counselor to support mental health and social emotional needs of our most at-risk students/families within the district. All students will have access to summer programming with the development of the summer student workshops and we will also specifically focus efforts for summer programming for our ELL students. A portion of these funds will also be allocated to a portion of an FTE to support foster care and homeless students throughout the district. To continue to support social emotional needs, we have allocated funds to purchase a multi-year license of SEcond Step, a program for K-8 students aimed at the development of social emotional competencies and skills. The funds will also be allocated to include the G2 "Grandparent" program for a Kindergarten room to support students' social and emotional development. Finally the funds will be used to purchase additional RedCat audiological systems which will support our students who have experienced hearing loss.

Since its creation in 2020, our district's Re-Opening/In-Person Learning Plan has been consistently updated and revised based on continuing guidance from the CDC, local health authorities, and the State Education Department. Under our district's Re-opening section on our website, we will have an email link to our Covid Director so that the public can send feedback, questions, comments, and ideas specific to in-person learning. We will also provide a comment section in our Re-Opening/In-Person Learning Plan so public comment can be reviewed and considered prior to any updates made to the plan at least every six months. Our Communications Team meets weekly to review items for in-person instruction and ensure parents get timely information about changes to our plan and structure to in-person learning.
